#### PROCEEDINGS

Proceedings of the Fifty-Ninth Annual Session of The Indian Bottom Association of Old Regular Baptists of Jesus Christ in session assembled with the Little Bethlehem Church Amburgey, Knott County, Kentucky, September 3, 4, 5, 1954.

The Association met at the place arranged for preaching and after singing some of Zions Songs, the service was introduced by Elder Alva Caudill, after which the introductory sermon was preached by Elder George Hagans, using the following text: Prov. Chapter 22, Verse 28. Remove not the ancient landmark, which thy fathers have set.

The delegation then assembled at the Church house and after singing by the congregation, introduction by Elder Johnny Hall and prayer led by Elder E. V. Hopkins proceed-

ed to business as follows:

1. The house was called to order by Elder G. M. Caudill the Moderator, who then called for the letters from the several churches that compose the Indian Bottom Association which were handed in to the clerk. One letter was read, then all of them were received and delegates seated, with all queries and requests referred to the committee on arrangements.

2. The Association then organized by choosing Elder G. M. Caudill, Moderator; Elder J. W. Pratt, Assistant Moderator; Brother Dawson Dixon, Clerk; and Elder H. D. Cau-

dill, Assistant Clerk.

- 3. Called for newly constituted churches and received none.
- 4. By move and second, the Rules of Decorum was read, but omitted reading the Constitution and Articles of Faith.
- 5. Called for corresponding letters from our Sister Associations and received the following:

UNION — with the following delegates: Elmer Church, Andy Bates M. L. Amburgey, Earl Belcher, J. Marshall Davis, Tyree Church and Earl Hogston. Letters in the hands of Elmer Church.

NEW SALEM — with the following delegates: J. P. Hall, E. H. Howard, E. V. Hopkins, M. V. Burke, Wiley Coffee, Curtis Frasure, Dan Gibson, Jerry Hall, Jr. J. M. Moore, and Jerry Hall, Sr. Letter in hands of Elder E. V. Hopkins.

PHILADELPHIA — with the following delegates:

Eales Cotton, John Moore, Glenn Rose, Virgie Burnett. and M. W. Burnett with letter in the hands of Elder Cales Cotton.

SARDIS — with the following delegates: Esther Hopkins, B. H. Bevins, and Edd May. Said letters with a file of minutes from all the above - named associations were received and the delegates extended the right hand of fellowship by our Moderator and given a seat with us.

- 6. Called for transient Ministers and members of our same faith and order and received as follows:
- H. L. Raleigh, Fayette Caudill, Frank Hall, Millard Allen, Clarence Fields, Henry Blair, Gordon Caudill, Alvin Hagans John W. Collins, E. F. Bentley, Talt Hall, Sherman Slone, J. T. Nichols, Paris Hagans, Monroe Couch, Jonah Tackett, Elam Hale, Marion Francis, William W. Francis.

7. On motion, the Moderator was authorized to make

all temporary appointments.

- 8. Appointed a Committee on Ministry, consisting of one Delegate from each Church with the entire delegation of the Little Bethlehem Church.
- 9. Appointed the same Committee on Arrangements as on Ministry with only one delegate from the Little Bethlehem Church, together with Moderator and Clerk and visiting brethren and transients invited.
- 10. On motion, the Clerk and Assistant Clerk were appointed to write Corresponding Letters to our Sister Associations.
- 11. Called on the Committee on Ministry to report, who reported the following Ministers to preach Friday evening: 1—Elbert Short; 2—Harrison Bevins; 3—Johnny Hall; Saturday, 1—Eales Cotton; 2—Earl Hogston; 3--Ester Hopkins; 4—E. V. Hopkins; 5—Elmer Church.
- 12. On motion the Association adjourned until 9:00 A. M., Saturday morning.

#### SATURDAY MORNING, SEPT. 4, 1954.

Met pursuant to adjournment and after singing by the congregation and prayer by Elder E. H. Howard, proceeded as follows:

1. Called the roll and marked the absentees.

2. Called for Transient Ministers and members of our same faith and order and received as follows: Woodrow Dye, Hager Watts, Troy Nichols and Lawrence Jenkins.

3. Ministers to preach at the stand were excused.

4. Called on the Committee on Arrangements to report. The report of this Committee was received and the

committee was discharged.

ITEM 1.—The report of the Committee which was sent to investigate records of the Oven Fork Church November the Second Saturday, 1953. The report of this Committee which is printed in this minute was received and the committee was discharged.

#### COMMITTEE'S REPORT

November 14, 1953.

The second Saturday of November 1953, this being the regular meeting time, the Oven Fork Church of Old Regular Baptist of Jesus Christ, met with a committee chosen by the Indian Bottom Association. The names of the delegates are as follows: Bros. John Moore of the Philadelphia Association, George Hagans, G. M. Caudill, and Beckham Fields of the Indian Bottom Association. These brethern were chosen to meet with the Ovn Fork Church for th purpose of examining the records of said church and to work with them in the love of God, and to help them restore peace, love, and fllowship among the church.

After introduction and prayer by Bro. Beckham Fields, and preaching by Bro. John Moore the committee met and chose Bro. G. M. Caudill moderator of the committee, and Bro. Alonzo Allen, Clerk of same. Bro. Manis Isom brought the question of fourteen members being excluded in 1950 and asked a solution to this problem which semed to be uppermost in the mind of the committee. Bro. John Moore came forward and seemed to be wonderfully blessed in his instructions and admonitions in regard to a solution.

Then Bro. Riley Fouts got permission from his moedrator to speak. Bro. Riley then made his acknowledgement to the church and to those that felt that he had wrongfuly treated them in dismissing them from the Oven Fork Church. He further stated he was willing to invite them all back to their seat and make his apology as the work was done contrary to Old Regular Baptist order and pretice.

Bro. George Hagans then came forward and being blessed by the power of the Holy Spirit gave th Church beautiful council asking them to go to those they had wronged out of their fellowship and labor with them, get them to come back home and to take up their fellowship again with

the Oven Fork Church and so continue in love one with another.. And those who have gone out elsewhere and taken up fellowship, if they will not com back to their church, call them in question, and exclude them.

It was then moved by Bro. Beckham Fields and seconded by Bro. George Hagans that we pass this item into the

hands of the committee.

Question: Why did the Oven Fork Church ask the Indian Bottom Association for letter to go to some other Association?

The answer given: Because some brethern spoke hastily and did not want to force orders of the Association upon members of the Oven Fork Church. They further stated that Bro. Ballard Baker had agreed to take them into the Unon Association by application according to Bro. Riley Fouts statement to the committee.

Bro. Albro Hubbard and Sster Bell Mullins stated that Bro. Fouts did not advise church to go to the Union Association, it was their own accord, but now the church is satisfied with the orders of the association and the majority of the church answered so.

Moved by Bro. George Hagans and seconded by Bro. Beckham Fields to close discussion on subject and turn same over to hands of committee.

Moved by Bro. George Hagans and seconded by Bro. Beckham Fields to adjourn and make up report of committee.

Committee now in conference:

Moved by Bro. George Hagans and seconded by Bro. Beckham Fields that the Oven Fork Church record the act of excluding those fourteen members of the Oven Fork Church without giving them a fair trial; we further request that Bro. Riley Fouts advise the church to make their acknowledgement as well as he himself to these brethern and sisters for injustice that thy did them and the way and manner with which they delt with them.

Item No. 2 — We further recommend that Brother Riley Fouts appear before the Indiana Bottom Association when it convenes with the Little Bethlehem Church on Irishman Creek, Knott county, Kentucky in september the first Friday and Saturday and Sunday, 1954, and make an acknowledgement to the delegation that he misinformed them and cause them to believe that he excluded fourteen members according to Old Regular Baptist discipline.

Moved by Brother Beckham Fields and seconded by

Brother G. M. Caudill that Brother Riley Fouts make an acknowledgement to the Indian Bottom Association for transgression against it by taking a church letter to the Union Association and asking them for admittance to their body after we, the Indian Bottom Association had refused them a letter of dismission.

Moved and seconded that the committee be disolved.

Done and signed by ordr of the committee.

By move and second the above report was unanously received and committee discharged.

We, the Association, say unanimously that we now withdraw our fellowship from the Oven Fork Church and cancel the credentials of Elder Riley Fouts, their Moderator for making false statements to The Indian Bottom Association, also for not obeying the advice given to him and the Oven Fork Church ond leading them into further disorder by abruptly breaking away from our Association and joining themselves to the Thornton Union Association. Therefore, we publish Riley Fouts and Oven Fork Church in disorder.

ITEM 2.—This association also withdraws its fellowship from the Maple Grove Church and publish her in disorder for abruptly breaking away from this association and joining herself to the Thorton Union Association.

ITEM 3.—By unanimous voice the Indian Bottom Association agreed to send an answer query and request to the Union Association, New Salem Association and Sardis Association which reads as follows:

## ANSWER QUERY AND REQUEST TO UNION. NEW SALEM and SARDIS ASSOCIATION

We the Indian Bottom Association of Old Regular Baptists of Jesus Christ now in session with the Little Bethlehem church of Amburgey, Knott county, Kentucky, September 3-4-5, 1954.

In answer to your request; we say that the Thornton Union Association has never complied with our request by giving us a direct answer to our request concerning cut or bobbed hair, and other differences as follows: They have

taken members into their fellowship who were legally excluded by us. They have also taken seven of our churches into their fellowship. One of thse churchs were under censure by us for her disorders and another had not been brought into question by us. The others were dropped from our fellowship for rebelling against the rules of our association.

We pray that you our beloved sister associations lo seriously consider this our answer—query and request and give us an answer whether you are going to indorse the actions of the Thornton Union Association for violating the rules of our association, and deviating frm the orthodox principles of religion, which is recorded in the 17th item of our constitution.

We therefore ask that you give us a direct answer Yes or No. If you feel to indorse the actions of the Thornton Union Association in her disorderly work; then give us our letter and we will not give you any more trouble.

#### TO THE INDIAN BOTTOM ASSOCIATION

Item 6. We received your request and it was read at the Committee of arrangements. There is nothing we can do as we are not in corrspondence with Thornton Union directly.

In answer to this request, we do not believe that the things mentioned in this letter are in line with Old Regular Baptist doctrine.

In answer to Item One, concerning bobbed hair. Our churches have no such practice, neither does the Church of God.

In answer to the question of Elders preaching with other denominations. We have the same order as you have.

In answer to the Sixth Item concerning secret orders. We have none that we know of and do not want any.

We hope that something can be worked out to bring about peace among our Sister Associations.

This letter is written by order of The Philadelphia Association.

In regard to query from the Powell Church asking that the Indian Bottom Association make peace with the Thornton Union Association to former suggestions of Elder F. A. Hopkins. It was moved, seconded and passed by unanimous voice of the Association as everything now

stands we cannot comply with their request.

Item 5. In regard to a query from the Reynolds Fork Church asking the Association to interpret the true meaning of several scriptures. After a brief discussion it was made manifest that this was desired for the benefit of some young preachers. It was the mind of the association that preachers should depend upon God to revelate their minds when they attempt to preach. If any among you lack wisdom, ask of God who givth liberally to all and upbraideth none. By move nd second, it was disposed of without further consideration.

- 5. Appointed a Committee on Finance consisting of Elders H. B. Reedy, Alva Caudill and Monroe Caudill who reported the sum of \$324.00 contributed by the several churches. By move and second Brothr Dawson Dixon was appointed treasurer and authorized to superintend the printing of 3,000 Minute Books and reserve 100 copies for each of our corresponding sister associations, and distribute the remainder among the several churches, according to their contributions and that he receive \$35.00 for his services and that he pay the assistant clerk \$20.00 for his services.
- 6. Appointed the same committee on Ministry as of yesterday to arrange for preaching Saturday evening and Sunday, which reported as follows: Saturday evening—1; James F. Collins; 2—Edd May; 3— James W. Pratt; Sunday: 1—H. B. Reedy; 2—M. V. Burke; 3—John Moore; 4—G. M. Caudill, the Moderator.
- 7. Letters to the Corresponding Associations were read and approved and delegates appointed to attend as follows: Union—to be held with the Bull Creek Church, Maxie, Buchannon county, Virginia, beginning on Friday before the third Saturday in September, 1954. #### CIRCULAR LETTER

Dear brothers and sisters of the Indian Bottom Association of Old Regular Baptist:

I will now try to comply with your request of our last

association. by writing this circular letter.

#### Constitution

Having by unanimous voice changed our organization from an Annual Union Meeting to an Association, we therefore propose to keep the order and rules of an Association according to the following form of government:

- 1. The Association shall be called the Indian Bottom Association.
- 2. The Association shall be composed of members chosen by the different churches in our union and duly sent to represent them in the Association, who shall be members whom they judge best qualified for that purpose, and producing letters from their churches certifying their appointment, shall be entitled to a seat.
- 3. In the letters from the different churches shall be expressed their full numbers in fellowship, those baptized, received by letter, restoration, application, dismissed, excluded and deceased since our last Association.
- 4. The members thus chosen and convened shall have no power to lord over God's heritage nor shall they have any clerical powers over the churches nor shall they infringe on any of the rights of any of the churches in the Union.
- 5. The Association when convened shall be governed by a regular and proper decorum.
- 6. The Association shall have a Moderator. Clerk and Treasurer who shall be chosen by the suffrage of the members present.
- 7. New churches may be admitted into the Union, which shall petition by letter and delegates and if found upon examination to be orthodox and orderly, shall be received by the Association and manifested by the Moderator and given the right hand of fellowship.
- 8. Every Church in the Union shall be entitled to representation in the Association.
- 9. Every querry presented by the churches to the Association, being first debated in their own churches shall come under the consideration of the Association.
- 10. Every motion made and seconded shall be considered by the Association except it be withdrawn by the party who made it.
- 11. We think it absolutely necessary that we have an Association fund for defraying the expenses of the same for the raising of which we think it the duty of each church in the Union to contribute such sums voluntarily as they think

proper and send it by their delegates to the Association, and the amount so received shall be deposited with the Treasurer, who shall be responsible to the Association and pay same out as the Association may direct.

12. There shall be an Association Book kept in which the proceedings of every Association shall be regularly re-

corded by the Secretary.

13. The Minutes of the Association shall be read and corrected if need be and signed by the Moderator and clerk before the Association arises.

14. Amendments to this plan of government may be made at any time by a majority of the Union when so desired.

15. The Association shall endeavor to furnish the churches with minutes of the Association. The best method of effecting same shall be determined by the Association.

16. All matters coming before the Association shall be decided by will of the majority of the members present except in receiving and dismissing churches and Associations

which shall be by unanimous vote.

17. The Association shall have power to decide for the General Union of the churches and to preserve an inviolable chain of communion among same, giving churches all necessary advice in matters of church difficulty; inquiring into the cause why any church shall have failed to represent itself at any time in the Association; appropriate the money received to any purpose it may think proper; appoint any member, or members by their consent to transact any business which it may think necessary; withdraw from any church in the Union which may violate any of the rules of the Association or deviate from the orthodox principles of religion, admit any orderly minister of our faith and order to a seat in the Association, and adjourn to any time or place it may deem necessary.

### Articles of Faith

- 1. We believe in the one true and living God. and not-withstanding there are Three that bear record in Heaven, the Father, the Son and the Holy Ghost, yet there is but one in substance. equal in power and glory, not to be divided and impossible to change in principle or practice.
- 2. We believe the Old and New Testament Scriptures are the true written Words of God and were given by inspiration of God and there is a sufficiency in them contained for

our instruction and they are the only rule of our faith, and practice.

- 3. We believe in the doctrine of original sin and that men sinned since the fall and are by nature the children of wrath.
- 4. We believe in the impotency of inability of man to recover themselves out of the state they are in; therefore a Saviour is absolutely needed.
- 5. We believe that sinners are justified in the sight of God only by imputed righteousness of Jesus Christ.
- 6. We believe in the perseverance of the Saints that through grace they are born again and adopted into the family of Heaven: that they become equal heirs with Jesus Christ in glory, and that He will raise them up at the last day.
- 7. We believe that Baptism and the Lord's Supper are Gospel Ordinances; that true believers are the proper subjects and we admit no other.
- 8. We believe that the true mode of baptism is by immersion to baptize a person by their own consent, back foremost in water in the name of the Father, the Son, and the Holy Ghost.
- 9. We believe that washing of one another's feet is a commandment of Christ, left on records with His Disciples, and ought to be practiced by his followers.
- 10. We believe in the resurrection of the dead and general Judgment when all will be judged according to their deeds done in the body.
- 11. We believe the punishment of the wicked will be everlasting and the joys of the righteous will be eternal after death.
- 12. We believe that no one has a right to administer the gospel ordinances but such as are legally called and qualified thereunto.
- 13. We believe it to be the duty of all church members to attend church meetings, and that it is the duty of the church to deal with them for neglecting the same.
- 14. We believe it to be the duty of all church members to contribute to the support of the church by defraying all reasonable expenses of same, never neglecting the poor, according to their several abilities.
- 15. We believe that any doctrine that goes to encourage or indulge the people in their sins or to cause them to settle down on anything short of saving grace in Christ for salva-

tion is erroneous and such doctrines will be rejected by us.

16. None of the above articles shall be construed as to hold with particular election or reprobation as to make God partial directly or indirectly so as to injure children of men.

17. None of the above articles shall be altered without

legal notice and free consent.

#### Rules of Decorum

1. The Association shall be opened and closed with prayer.

2. A Moderator and Clerk shall be chosen by the

suffrage of the members present.

3. Only one member shall speak at a time and shall rise from his seat and address the Moderator when about to speak.

4. The person speaking shall not be interrupted in his speech by anyone except the Moderator until he is done

speaking.

5. He shall strictly adhere to his subject and in nowise reflect on the preceding speaker, but shall define his ideas on the proposition for debate as far as he can.

6. No person shall abruptly absent himself from the

Association without leave of same.

7. No person shall rise and speak more than three times on any subject without permission of the Association.

8. No member of the Association shall have liberty to laugh during the sitting of the same nor whisper in time of public speech.

9. No member shall address any other by any other

name or term than that of "Brother".

- 10. The names of the several members shall be enrolled by the clerk and called over as the Assocation may require.
- 11. The Moderator shall not interrupt or prohibit a member from speaking until he gives his views on the subject. unless he shall have violated the Rules of Decorum.
- 12. The Moderator shall be entitled to the same privilege of speech as another member, provided the chair be filled, but he shall have no vote unless the Association be equally divided. In that event he shall give the casting vote.
- 13. Any member who shall willingly and knowingly violate any of these rules shall be reprimanded by the Association as it may think proper.


