PROCEEDINGS:

Proceedings of the Sixty-Second Annual Session of the Indian Bottom Association of Old Regular Baptists of Jesus Christ in session assembled with the Powell Church, Waynesburg, Lincoln County, Ky., Sept. 6, 7, and 8, 1957.

The Association met at the place arranged for preaching and after singing some of the old songs of Zion by the congregation and in introduction and prayer by Elder H. B. Reedy; the introductory sermon was preached by Elder Beckham Fields, who didn't take any particular text but preached a wonderful sermon.

The delegates then assembled at the church house and after singing by the congregation and inspiring remarks of introduction by Elder B. H. Baker and prayer by Elder Baxter Osbourne, proceeded as follows:

- 1. The house was called to order by Elder J. W. Pratt, the Moderator, who then called for the letters from the several churches that compose the Indian Bottom Association, which were handed in to the Clerk. One letter was read by the Assistant Clerk. Then all the letters were received and delegates seated with queries and requests referred to the committee on arrangements.
- 2. The association then organized by choosing Elder J. W. Pratt, Moderator; Elder George Hagans, Assistant Moderator; Brother Dawson Dixon, Clerk and Elder H. D. Caudill, Assistant Clerk.
 - 3. Called for newly organized churches and received none.
- 4. Reading of Constitution, Articles of Faith and Rules of Decorum—omitted.
- 5. Called for letters from corresponding Sister Associations and received as follows:
- (a) UNION—Represented by the following delegates: Elmer Church, B. H. Baker, John Hess, Tyra Church, J. M. Mullins, Marshall Davis, and Earl Hogston.
- (b) NEW SALEM—Represented by the following delegates: Roy B. Akers, Hager Watts, Bert Howard, Dan Gibson, Coy Combs, Baxter Osbourne, Perry Tackett, Hassel Caudill, Walter Mullins.
- (c) SARDIS—Represented by the following delegates: Tracy Hatfield, Harold Varney, and Ralph Varney.

(d) PHILADELPHIA—Represented by the following delegate: John Moore.

The letters from the above named associations were read and received and delegates seated.

- 6. The letter from the Thornton Union Association with a petition saying that they would drop from their fellowship all members and churches taken from the Indian Bottom Association; with the understanding that after they remained with us for one year they are to have the privilege of asking for, and eligible to receive a letter of dismission. In this petition they did not say that they would have their Sisters stop cutting their hair or have their Ministers stop preaching with disorderly preachers sects and denominations. Their letter and petition was rejected because they had not fully complied with the advice given them by their mother, the Union Association.
- 7. Called for transient ministers and members of our same faith and order and received the following: Andy Bates, H. B. Reedy, Hiram Amburgey, Millard Allen, Paris Hagans, Gordon Caudill, Noah Eldridge and Clarence Fields.
- 8. On motion the Moderator was authorized to make all temporary appointments during this session of the association.
- 9. Appointed a Committee on Ministry consisting of one delegate from each church with the entire delegation from the Powell Church.
- 10. Appointed the same committee on arrangements as on ministry with only one delegate from the Powell Church with Moderator, Clerks, visiting brethren and transients invited.
- 11. On motion the Clerk and Assistant Clerk were appointed to write corresponding letters to Sister Associations as follows: Union, New Salem, Philadelphia, Sardis and Mud River.
- 12. Called on the Committee on Ministry to report who reported the following Ministers to preach; Friday evening: 1. Coy Combs; 2. Troy Hatfield; 3. Tyra Church. Saturday: 1. Burton Howard; 2. John Hess; 3. Baxter Osbourne; 4. B. H. Baker; 5. Elmer Church.
- 13. On motion the Association adjourned until 9:00 a.m., Saturday morning, Sept. 7.

Saturday Morning, Sept. 7, 1957

Met pursuant to adjournment and after singing by the congregation and introduction and prayer by Elder John Moore proceeded to business as follows:

- 1: Called the roll and marked the absentees.
- 2. Called for transient Ministers and members of our same faith and order and received Elder C. C. Bates.
 - 3. Ministers to preach at the stand were excused.
- 4. Called on the committee on arrangements to report. The report was received and the committee discharged.
- 5. Appointed a committee on finance consisting of Manus Ison, James Whitaker and Beckham Fields, who reported the sum of \$363.00 contributed by the churches. Then by move and second Brother Dawson Dixon was appointed treasurer and authorized to superintend the printing of 2500 Minute Books and reserve 50 copies for each of our corresponding Sister Associations and distribute the remainder among the churches according to their contributions. That he receive \$35.00 for his services and pay Elder H. D. Caudill \$20.00 as Assistant Clerk.
- 6. Appointed the same Committee on Ministry as of yesterday to arrange for preaching Saturday evening and Sunday, which reported as follows: Saturday evening 1. Roy Whitaker; 2. Paris Hagans. Sunday: 1. H. B. Whitaker; 2. John Moore; 3. George Hagans and 4. J. W. Pratt.
- 7. Letters to the corresponding associations were read and approved and delegates appointed to attend as follows:

- 11. The Circular Letter written by Elder Olus Baldridge was read and approved and ordered to be printed in our Minutes.
- 12. On motion Brother McKinley McIntosh was appointed to write a Circular Letter for next year.
- 13. On motion it was agreed that the next session of the Association be held with the Big Leatherwood Church, Cornetts-ville, Perry County, Ky. To begin on Friday before the first Saturday in September, 1958 and continue the two following days. The Introductory Sermon to be preached by Elder Olus Baldridge and Elder Alonzo Allen to be his alternate.
- 14. On motion the Association was closed by prayer by Elder H. D. Caudill and adjourned to the time and place of our next association.

CIRCULAR LETTER

Dear Brethren of the Indian Bottom Association of Old Regular Baptists of Jesus Christ, believing that you could have made a much better choice in selecting one to write a circular letter but being willing to be submissive to my good brethren, I will make an humble effort to write one, trusting that the Almighty God will remember my prayers and guide my mind by His Spirit to do so.

Since there is a scripture that is uppermost in my mind I will try to write a few words on the subject. It is Isaiah: 31-3, "Woe to them that go down to Egypt for help; and stay on horses and trust in chariots because they are many; and in horsemen because they are strong; but they look not to the Holy One of Israel neither seek the Lord."

Now I want to call your attention to the fact that Egypt is a type or figure of the world, or as Isaiah 31:3 says: Now the Egyptians are men and not God, and their horses flesh and not Spirit. We begin to see what the Prophet was speaking about is that: men trusting in men to save them, not having came down from their high and lofty state in humble submission before the throne of grace and being born again by the Spirit of God.

Men who have gone in the way of Cain and ran greedily after the error of Balaam for reward, men who have gone to the seminary to learn how to preach, yes they have gone down into Egypt for help, they have trusted in chariots, (chariots are devices of men for the purpose of carrying men about).

Men who have set up so called Churches throughout the world; and saying lo here is the way or there is the way, but Christ said go not after them.

They have taken every name that they can think of that will attract the minds of men, but God named His people by a new name and I believe it was Baptist.

Now I will have to try to explain why I believe this. Among

many reasons here are a few or rather one of them.

John the Baptist came preaching in the wilderness of Judea, saying, "Repent ye for the Kingdom of Heaven is at hand!" John was a man sent from God, and his mission was to make ready a people prepared for the coming of the Lord, and as had said the prophet: "To turn the heart of the fathers to the children, and the heart of the children to their fathers, lest he Lord come and smie the earth with a curse." (Mal. 4:6).

John did indeed baptize in water, but he (John) said there cometh one after me, who is mightier than I and He will baptize you with the fire and the Holy Ghost. Now we see that Christ was a Baptist being baptized by John and not only that but the greatest baptizer of all, the administrator of the baptism that will reach and save the souls of people.

So John's baptism which was water was a figure of the one to come when those whom John had baptiszed for the remission of their sins would receive the Holy Ghost Baptism.

But now we are baptised in water to show forth that we have already received the Holy Ghost Baptism and that we are no more of the world, having been crucified to the things of the world, having been buried in the likeness of His burial, and been raised to walk in the newness of life, in the likeness of His resurrection from the dead.

So now we see where men must go to get help, not to men but to God through His Son. not in a high mind but humble, not in mens devices but by God's plan, our souls being saved by the Blood of the everlasting covenant and our bodies having a promise from One who never fails, that He will raise them up at the last day.

I believe that we are now dwelling in the land of Egypt (in a figure), but God has said: "Out of Egypt have I called my Son." Yes, He called Him out in the days of Moses. He being a figure of Christ and they were baptized unto nim (Moses) in the Red Sea. He led them up out of Egypt, yes He called Him out again when His Son Jesus was taken three by Joseph and Mary to escape the wrath of King Herod. Yes He called Him out again when His Son lay in the heart of the earth three days.

Yes He calls every man and woman to come up out of egypt, but few obey, and those who do are made His sons. (Gal. 3:26-27-28-29). For ye are the children of God by faith in Christ Jesus. For as many of you as have been baptized into Christ have put on Christ. There is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female, for y are all one in Christ Jesus and if ye be Christs, then ye are Abraham's seed and heirs according to the promise.

Now some may ask, saying what was the promise? Genesis

12:3: "And I will bless them that bless thee and curse him that curseth thee: and in thee shall all families of the earth be blessed."

And also, Gen. 15-13-14: "And He said unto Abram, know of a surety that thy seed shall be a stranger in a land that is not theirs, and shall serve them; and they shall afflict them four hundred years; and also that nation whom they shall serve will I judge; and afterwards shall they come out with great substance."

Yes this was the promise that God would not leave His people in Egypt, but would bring them forth with great substance, in the resurrection day with a body that can't die a glorified one, one fit to go to Heaven in. Yes God will call His Son out of Egypt when He has heard their cries and groans long enough, and sends Jesus to bring them home. No matter how long they may have dwelt in the dust the prophesy will be brought to pass: Oh grave where is thy victory; Oh death where is thy sting.

And then God's judgment upon that nation (the world) who have so evilly treated His people shall be poured out as Paul says in 2nd Thes. 1:7-8-9: "And to you who are troubled rest with us, when the Lord Jesus shall be revealed from Heaven with His mighty Angels, in flaming fire, taking vengence on them that know not God and that obey not the Gospel of our Lord Jesus Christ, who shall be punished with everlasting destruction from

the presence of the Lord and the Glory of His power.

And so, dearly beloved Brethren and Sisters, as the Apostle Peter wrote in 1st Peter: 4-12: "Beloved think it not strange concerning the fiery trial which is to try you, as though some strange thing happened unto you; but rather rejoice, inasmuch as ye are partakers of Christ's suffering." Yes sometimes the load gets heavy and the burden hard to bear, but let's look back through the ages at God's people, who have bourne the burden in the heat of the day. Men like Abraham, Isaac, Jacob, Joseph and Moses. Also men like Gideon, Samson, Jephthae, David also, and Samuel and all the prophets that time fails me to tell, whom as Paul says were tortured, had trial of cruel mocking and scourgings yea, moreover bonds of imprisonment. They were stoned, they were sown asunder, were tempted, were slain by the sword, they wandered about in sheepskins and goatskins, being destitute, afflicted, tormented (of which the world was not worthy), they wandered in deserts and in mountains and in caves and dens of the earth.

And now we clearly understand that we must expect suffering, sorrow and trials here in this world, that we may receive a crown in the end. For as Paul said in Romans 8-18, 19, 20, 21, 22, 23. For I reckon the suffering of this present are not worthy

to be compared to the glory which shall be revealed in us. For the earnest expectation of the creature waiteth for the manifestation of the sons of God. For the creature was made subject to vanity, notwillingly, but by reason of him who hath subjected the same in hope, because the creature itself also shall be deliverd from the bondage of corruption into the glorious liberty of the children of God. For we know that the whole creation groaneth and travaileth in pain together until now. And not only they but ourselves also, which have the first fruits of the Spirit even we ourselves groan within ourselves, waiting for the adoption, to wit the redemption of our body.

And now we also understand why so many go down into Egypt for help its because that its a promise of an easy way, a way wherein they can still enjoy the pleasures of sin, a worldly

way that will lead them to destruction.

So now Brethren, Sisters and Friends I will bring my remarks to a close trusting that you can understand my awkward way of explaining my subject, and may the God of peace that brought again from the dead our Lord Jesus that great shepherd of the sheep through the blood of the everlasting covenant. Bless you all until we meet again whether it be here in this troubled world or over on Canans happy shore.

Constitution

Having by unanimous voice changed our organization from an Annual Union Meeting to an Association, we therefore propose to keep the order and rules of an Association according to the following form of government:

1. The Association shall be called the Indian Bottom Association.

- 2. The Association shall be composed of members chosen by the different churches in our union, and duly sent to represent them in the Association, who shall be members whom they judge best qualified for that purpose, and producing letters from their respective churches, certifying to their appointment, these shall be entitled to a seat.
- 3. In the letters from the different churches shall be expressed their full number in fellowship, those baptized, received by letter, restoration, application, dismissed, excluded and deceased since our last Association.
- 4. The members thus chosen and convened shall have no power to lord over God's heritage nor shall they have any clerical powers over the churches nor shall they infringe on any of the rights of any of the churches in the Union.

5. The Association, when convened, shall be governed by a regular and proper decorum.

6. The Association shall have a Moderator and Assistant Moderator, Clerk, and Assistant Clerk, and Treasurer, who shall be chosen by the suffrage of the members present.

- 7. New churches may be admitted to this union, which shall petition by letter and delegates, and if found, upon examination to be orthodox and orderly, shall be received by the Association, and manifested by the Moderator giving the right hand of fellowship.
- 8. Every church in the union shall be entitled to representation in the Association.
- 9. Every query presented by the churches to the Association, being first debated in their own church, shall come under the consideration of the Association.
- 10. Every motion made and seconded shall be considered by the Association, except it be withdrawn by the party who made it.
- 11. We think it absolutely necessary that we have an Association fund, for defraying the expenses of the same, for the raising of which we think it the duty of each church is proper, and send it by their delegates, to be deposited with Treasurer, who shall be responsible to the Association for any pay the same out as the Association may direct.
- 12. There shall be an Association Book kept in which the proceedings of every Association shall be regularly recorded by the Secretary, who shall receive annual compensation for same.
- 13. The Minutes of the Association shall be read and corrected, if need be, and signed by the Moderator and Clerk before the Association rises.
- 14. Amendments to this plan of government may be made by a majority of the Union when in regular session, when so desired.
- 15. The Association shall endeavor to furnish the churches with Minutes of the Association, the best method of effecting the same shall be determined by the Association.
- 16. All matters coming before the Association shall be decided by will of the majority of the members present except in receiving and dismissing churches and Associations, which shall be by unanimous vote.
- 17. The Association shall have power to decide for the General Union of the churches and to preserve an inviolable chain of communion among same, giving churches all necessary advice in matters of church difficulty; inquiring into the cause why any church shall have failed to represent itself any time in the Association; appropriate the money received to any purpose it may think proper; appoint any member, or members by their consent to transact any business which it may think necessary; withdraw from any church in the Union which may violate any of the rules of the association or deviate from the Orthodox principles of religion, admit any orderly minister of our faith and order to a seat in the Association, and adjourn to any time or place it may deem necessary.

Articles of Faith

- 1. We believe in the one true and living God, and not withstanding there are Three that bear record in Heaven, the Father, the Son, and the Holy Ghost, yet there is but one in substance, equal in power and glory, not to be divided and impossible to change in principle or practice.
- 2. We believe the Old and New Testament Scriptures are the true written Words of God and were given by inspiration of God and there is a sufficiency in them contained for our instruction and they are the only rule of our faith and practice.
- 3. We believe in the doctrine of original sin and that men sinned since the fall and are by nature the children of wrath.
- 4. We believe in the impotency of inability of man to recover themselves out of the state they are in; therefore, a Saviour is absolutely needed.
- 5. We believe that sinners are justified in the sight of God only by imputed righteousness of Jesus Christ.
- 6. We believe in the preservance of the Saints that through grace they are born again and adopted into the family of Heaven; that they become equal heirs with Jesus Christ in glory, and that He will raise them up at the last day.
- 7. We believe that Baptism and the Lord's Supper are Gospel Ordinances; that true believers are the proper subjects and we admit no other.
- 8. We believe that the true mode of baptism is by immersion to baptize a person by their own consent, back foremost in water in the name of the Father, the Son, and the Holy Ghost.
- 9. We believe that washing of one another's feet is a commandment of Christ, left on records with His Disciples, and ought to be practiced by his followers.
- 10. We believe in the resurrection of the dead and general judgment when all will be judged according to their deeds done in the body.
- 11. We believe the punishment of the wicked will be everlasting and the joys of the righteous will be eternal after death.
- 12. We believe that no one has a right to administer the Gospel Ordinances but such as are legally called and qualified there unto.
- 13. We believe it to be the duty of all church members to attend church meetings, and that it is the duty of the church to deal with them for neglecting the same.
- 14. We believe it to be the duty of all church members to contribute to the support of the church by defraying all rea-

sonable expenses of same, never neglecting the poor, according to their several abilities.

15. We believe that any doctrine that goes to encourage or indulge the people in their sins or to cause them to settle down on anything short of saving grace in Christ for salvation is erroneous and such doctrines will be rejected by us.

16. None of the above articles shall be construed as to hold with particular election or reprobation as to make God partial

directly or indirectly so as to injure children of men.

17. None of the above articles shall be altered without legal notice and free consent.

Rules of Decorum

- 1. The Association shall be opened and closed by prayer.
- 2. The Moderator and Clerk shall be chosen by the suffrage of the members present.
- 3. Only one member shall speak at a time, and shall rise from his seat and address the Moderator, when he is about to speak.
- 4. The person thus speaking shall not be interrupted in his speech by anyone except the Moderator until he is done.
- 5. He shall strictly adhere to his subject and in nowise reflect on the preceding speaker, but shall define his ideas on the proposition for debate, so far as he can.
- 6. No person shall abruptly absent himself from the Association without leave of the same.
- 7. No person shall rise and speak more than three times on any subject without permission from the Association.
- 8. No member of the Association shall have the liberty to laugh during the sitting of the same, nor to whisper in time of public speech.
- 9. No member shall address another in any other form or term than that of "brother."
- 10. The Moderator shall not interrupt a brother or prohibit him from speaking until he gives his views on the subject unless he shall violate the Rules of Decorum.
- 11. The names of the several members of the Association shall be enrolled by the Clerk, and called as often as the Association may require.
- 12. The Moderator shall be entitled to the same privilege of speech as any other member, provided the chair be filled, but he shall have no vote unless the Association be equally divided in which event he shall give the deciding vote.
- 13. Any member who shall willfully and knowingly violate any of these rules shall be reprimanded by the Association as it may think proper.
