PROCEEDINGS:

FRIDAY, SEPTEMBER 1, 1961

Waynesburg, Lincoln County, Kentucky

Proceedings of the 66th annual session of the Indian Bottom Association of Old Regular Baptist, the Church of Jesus Christ, in session assembled with the Powell Church, Waynesburg, Lincoln County, Kentucky.

After remarks and prayer by Elder Carl Back, and introduction by Elder Alonzo Allen, who preached repentance to simpers and love toward brothers and sisters, Elder Steve Osborne of the Northern New Salem Association, very ably led in prayer opening the 66th session of the Indian Bottom Association. The association was then called to order by our beloved moderator, Elder J. W. Pratt, who called for the letters of the several churches that compose the Indian Bottom Association.

1. It was moved and seconded that we read the letter of the Powell Church, receive all the letters, seat the delegates, and refer the queries and requests to the committee on arrangements. Then proceeded the reading of the letters, receiving same, and seating delegates.

2. The association then organized by electing Elder J. W. Pratt, moderator; Elder Beckham Fields, assistant moderator; Elder Alonzo Allen, clerk and Elder Olus Baldridge, assistant clerk.

3. Called for newly organized churches and received none.

4. Called for letters of churches that wished to take up correspondence with us, and received one from the Friendship Church with a letter of dismission from the New Salem Association. Letter of application and the letter of dismissal read. It was moved and seconded to receive and seat their delegates.

5. Moved and seconded to omit reading of articles of faith, rules of decorum, and constitution but to have same printed in minutes.

5. Called for letters from corresponding associations and received the following:

A. Thornton Union Association with delegates: Elders Kirby Isom, Raymond Collins, James Wright, Jack Davidson, Jack Brown, Carl Duty, Billy Day, letter in hand of Elder Ray Collins. Letter was read. A move and second was made to receive same and seat their delegates.

B. Northern New Salem with delegates: Elders Baxter Osburn, Ray B. Akers, Steve Osborne, Saval Combs, Bros. Banner Collins, Van B. Hall, Hershel Sturgill, Hiram Osborn, Dave Fullum and Bill Collins, the letter in the hands of Roy B. Akers. The letter was read and it was moved and seconded to receive same and seat their delegates.

C. Called for the letter of Philadelphia Association and received report from Elder Alonzo Allen concerning same which was as follows: they rejected our letter against the advice of their moderator, Eld. John Moore.

D. Called for letter from Mud River Association and also received a report from Elder Alonzo Allen concerning same as follows: they also rejected our letter against the advice of their moderator and clerk, Elder Emory White and Wetzel Ball.

E. Called for transients from our sister associations to whom we had not yet lettered, and received the following: (a) New Salem, Elder Burton Howard, Bros. Hagar Watts and Reece Bolen; (b) Union, Elder Charlie Gibson and Brother Hendrix Hampton; (c) Sardis, not represented.

F. Transient ministers and members wishing to take a seat with us and received, Brethren Hershel Baldnidge, Powell Pratt, Worley Cornett,

Vernon Harper and Lovell Polley.

- 7. Moved and seconded that moderator make all temporary appointments.
- 8. Appointed one delegate from each church with entire delegation from Powell Church as committee on ministry to arrange for preaching Friday night and Saturday morning.
- 9. Appointed same committee on arrangements as on ministry with only one delegate from Powell Church with moderators, clerks, and delegates from our sister associations and transients invited to meet and arrange the work for Saturday morning.
- 10. Called for committee on ministry to report who reported as follows: (a) Ministers to preach Friday evening: Hiram Osborne, Kirby Isom, Burton Howard; Saturday morning: Roy B. Akers, Ray Collins, Steve Osborne and Baxter Osborne.

On motion the association adjourned until 9:00 o'clock Saturday morning, Sept. 2, 1961.

SATURDAY MORNING, SEPTEMBER 2, 1961

The association met pursuant to adjournment, and after singing some beautiful songs of Zion, introduction was ably made by Elder James Wright of Thornton Union Association, and prayer by Elder Charlie Gibson of Union Association. Then proceeded by Bro. moderator calling the association to order.

- 1. Called the roll and marked the absentees.
- 2. Called for transient ministers and members and received none.
- 3. Called for committee on arrangements to report. The report received and committee discharged.
- 4. In regard to the request of Little Dove Church, it was moved and seconded not to grant their request, but if they still desired a letter of dismission next year it would be granted. The reason for not granting the request of Little Dove Church at this time was because of the condition of the association in regard to correspondence.
- 5. In regard to the request of Cedar Grove Church concerning 17th item of constitution, it was moved and seconded to let item read as it is.
- 6. In regard to requests of Reynolds Fork and Kingdom Come churches for the 1962 session of the Indian Bottom Association, it was moved and seconded that the association be held with the Kingdom Come Church.
- 7. Appointed committee on finance consisting of Brethren James Whitaker, James Wright, and Carl Back, who reported the sum of \$215.00 from the several churches.
- 8. It was moved and seconded to have 1,500 copies of the minutes printed and that Elder Alonzo Allen superintend printing of same.
- 9. Appointed same committee on ministry as on Friday to choose ministers to preach on stand and also to choose minister to preach introductory sermon in 1962 and his alternate. It was reported as follows: (a) for Saturday night: Elders Carl Duty, James Wright and Perry Tackett; (b) for Sunday: Elders Alonzo Allen, Olus Baldridge and Beckham Fields; (c) appointed Elder Beckham Fields to preach introductory sermon and Elder Manis Isom to be his alternate.
- 10. It was moved and seconded to appoint clerk as secretary-treasurer and he is to receive \$35 and assistant clerk \$20 for their services.

- 11. Circular letter read by Elder Olus Baldridge; it was moved and seconded to receive same and have it printed in our minutes. By the same move Elder Carl Back was appointed to write circular letter for inspection of the association next year.
- 12. Treasury Report: Balance on hand last year, \$379.25; cost of printing minutes, \$295.00; cost of printing letter forms, \$15.00. Total expenses, \$310.00. Balance on hand, \$69.25; received from the several churches, \$215.00; received for pictures, \$30.00. Balance in treasury September 2, 1961, \$314.25.
- 13. Moved and seconded that we correspond with the following association and that the clerk, Eld. Alonzo Allen, prepare letters to same: New Salem, Union Sardis, Northern New Salem, Thornton Union, and Philadelphia.
- A. New Salem to be held with the Island Creek Church, Pikeville, Pike County, Ky., to commence on Friday before the fourth Saturday of September, 1961 and the two following days. Delegates sent: Elds. Beckham Fields, Manis Isom, Alonzo Allen, Olus Baldridge, Bros. Jerome Watts, Hershel Baldridge, J. B. Eversole, and Arthur Slone, letter in hand of Alonzo Allen.
- B. Union to be held with the Bethel Church, Jenkins, Letcher county, Ky., commencing on Friday before the third Saturday in September and the two following days. Delegates sent: Elders J. W. Pratt, Beckham Fields, Riley Fouts, Manis Isom, Crit Eldnidge, Henry Eldridge, Carl Back, J. B. Eversol, James Caudill, Lawrence Sumpter, Riley Fouts, Brent Logan, Jerome Watts, Hershel Baldridge, Albro Hubbard, Olus Baldridge and Alonzo Allen, letter in hands of J. W. Pratt.
- C. Sardis to be held with the Dix Fork Church, Canada, Pike County, Ky., to commence on Friday before the second Saturday in September and the two following days. Delegates Elders: J. W. Pratt, Manis Isom, Beckham Fields, Olus Baldridge, Alonzo Allen, J. B. Eversole, Arthur Slone, Jerome Watts, Rilley Fouts, Rershel Baldridge. Letter in hands of Alonzo Allen.
- D. Northern New Salem to be held with the Little Memory Church, Sunman, Ripley county, Indiana to commence on Friday before the first Saturday in August, 1962 and the two following days. Delegates sent, Elders Perry Tackett, B. F. Tackett, J. W. Pratt, Beckham Fields, Manis Isom, Crit Eldridge, Henry Eldridge, Riley Fouts, J. D. Cornett, Gardner Gent, Olus Baldridge, Alonzo Allen, Jerome Watts and Hershel Baldridge, letter in hands of Olus Baldridge.
- E. Philadelphia to be held with the South Fork Church, Worthington, Greenup county, Ky., to commence on Friday before the second Saturday in August, 1962 and the two following days. Delegates sent: Elders J. W. Pratt, Beckham Fields, Carl Back, James Caudill, Manis Isom, Olus Baldridge, and Alonzo Allen, letter in hands of Olus Baldridge.
- F. Thornton Union to be held with the Thornton Church, Mayking, Letcher county, Ky., to commence on Friday before the third Saturday in August, 1962 and the two following days. Delegates sent: Elders Riley Fouts, J. W. Pratt, Manis Isom, Beckham Fields, Carl Back, Crit Eldridge, Gardner Gent, Perry Tackett, Olus Baldridge, Alonzo Allen, and Brethren Henry Aldridge, Brent Logan, Hershel Baldridge and Jerome Watts. Letter in hands of Manis Isom.

- 14. Moved and seconded to have union meetings and communion time printed in minutes.
- 15. Called on brethren to report who had been appointed in union meetings and associations. They reported they had been as faithful as they could. The report was received. A move and second was made to excuse their failures.
- 16. Moved and seconded to omit reading of minutes in order to redeem time.
- 17. Moved and seconded that we adjourn to the time and place of the next session of the Indian Bottom Association.
- 18. The 66th session of the Indian Bottom Association was closed by many wonderful remarks by Elder Baxter Osborn of Northern New Salem Association and prayer by Elder Charlie Gibson of Old Union Association.

SUNDAY, SEPTEMBER 3, 1961

There was much love and great rejoicing manifested through handshaking, shouting and praising the Lord!

CIRCULAR LETTER

Dear brethren of the Indian Bottom Association, it being moved, seconded, and passed by the delegates of this association when met in our special session in last April that I write (for your approval or disapproval) a circular letter, and after much prayerful consideration, I at times did think that I would not even make this feeble attempt. But remembering that two of my dearly beloved brethren and much loved by this and our corresponding association's brethren, made and seconded the move that put this duty upon me, have since been taken from our fond embraces and the troubled shores of this life and their souls are resting in the glorious regions of God, and their bodies asleep in Jesus awaiting the redemption to wiit: the resurrection day.

And so to the memory of Elder Cephus Mosley and Brother John Smith I dedicate this humble attempt. And knowing these worthy brothers' lives, and their love for the LORD and His Church and their deep concern that love and peace should abound among the brothers and sisters, I will try to write a few words on this subject.

First of all we hear Jesus Himself saying: John 15 beginning at the 10th verse, "If ye keep my commandments, ye shall abide in love; Even as I have kept my Father's commandments, and abide in His love. These things have I spoken unto you and that your joy might be full.

This is my commandment, That ye love one another as I have loved you."

Jesus goes on to say that "Greater love hath no man than this that a man lay down his life for his friends, and ye are my friends if ye do whatsoever I command you."

So by these words we see that we are commanded to love one another and thereby reap the reward of our time salvation in the joyful blessings of the Lord. Otherwise we cannot even be called His friends.

We also hear Jesus saying in Matt. 23rd verse, 5th chapter, "Therefore if thou bring thy gift to the altar, and there rememberest that thy brother hath ought against thee. Leave there thy gift before the altar and go thy way: First be reconciled to thy brother then come offer thy gift."

I believe the gift or offering spoken of is our spiritual offerings whether in singing, prayer, or preaching or any other spiritual work, so in this there is small wonder that preachers sometimes wound the congregation by hurtful speech and villifying, they had not kept the Lord's commandment and therefore could not receive a blessing, for I John I. 9: says: "He that saith he is in the light and hateth his brother is in darkness even until now. But, he that loveth his brother abideth in the light and there is none occasion of stumbling in him."

Paul says, "For all the law is fulfilled in one word even in this: Thou shalt love thy neighbor as thy self."

So dear brethren let's do all that lies within us to keep the Lord's commandment even to loving them that hate us; praying for them that

despitefully use us, showing our love one for another that all men may know that we are His disciples, always remembering to lend a helping hand to those that are weak, for there be many travellers from Jerusalem to Jericho who need a neighbor along the rugged way. Let's keep in mind the beautiful parable of the Good Shepherd and the hundred sheep and the one that went astray.

For we read in Galatians 6.I: "Brethren, if a man be overtaken in a fault, ye which are spiritual restore such a one in the spirit of meekness, considering thyself, lest thou also be tempted". By this I believe to be spiritual is to have love for one another, for we also read in Gal. 5.22: "But the fruit of the spirit is love, joy, peace, long suffering, gentleness, goodness, faith, meekness, temperance; against which there is no law."

Brethren I want you to take note of the above scriptures and study them diligently for space will not permit me to write all that could be said of each of those wholesome words.

But on the other hand consider what the works of the flesh are: That is not to possess the spirit or to work in the spirit; Gal. 5.19 says: "Now the works of the flesh are manifest which are these; Adultery, fornication, uncleanness, lasciviousness, idolatry, witchcraft, hatred, variance, emulation, wrath, strife, seditions, heresies, envying, murders, drunkenness, revelling and such like, of the which I tell you before as I have told you in time past that they which do such things shall not inherit the kingdom of God."

Now study also these, especially the definitions to the words: variance, emulation, sedition and heresy, and you can see why this old church suffers so much violence even now in these last days thereby fulfilling the scriptures, which say that because iniquity shall abound the love of many shall wax cold. Now the word iniquity means sin in which all the above words are encompassed

Yes, my dear brethren, the time is at hand when you and I and every child of God should be about the Father's business, for the day is evil, the time is short and many of our children and our friends are not ready to meet Him in Peace. We have no time to be smiting our fellow servants for the Lord will come at an unexpected time for those who do. So let's you and I gird on the whole armor and march toward Canaan's happy shores, always asking the Lord to lead us in all things and to help us win the victory, FOR THE CAUSE IS HIS. So farewell, my dear brethren, and may the Lord ever bless and keep you all is the prayer of your humble servant.

ARTICLES OF FAITH

- 1. We believe in the one true and living God, and not withstanding there are Three that bear record in Heaven, the Father, the Son and the Holy Ghost, yet there is but one in substance, equal in power and glory, not to be divided and impossible to change in principle or practice.
- 2. We believe the Old and New Testament Scriptures are the true written words of God and were given by inspiration of God and there is a sufficiency in them contained for our instruction and they are the only rule of our faith and practice.
- 3. We believe in the doctrine of original sin and that men sinned since the fall and are by nature the children of wrath.

- 4. We believe in the impotency of inability of man to recover themselves out of the state they are in; therefore, a Saviour is absolutely needed.
- 5. We believe that sinners are justified in the sight of God only by imputed righteousness of Jesus Christ.
- 6. We believe in the perseverence of the Saints. That by grace through faith they are born again and adopted into the family of Heaven; that they become equal heirs with Jesus Christ in glory, and that He will raise them up at the last day.
- 7. We believe that Baptism and the Lord's Supper are Gospel Ordinances: that true believers are the proper subjects and we admit no other.
- 8. We believe that the true mode of baptism is by immersion to baptize a person by their own consent, back foremost in water in the name of the Father, the Son, and the Holy Ghost.
- 9. We believe that washing of one another's feet is a commandment of Christ, left on records with His Disciples, and ought to be practiced by his followers.
- 10. We believe in the resurrection of the dead and general judgement when all will be judged according to their deeds done in the body.
- 11. We believe the punishment of the wicked will be everlasting and the joys of the righteous will be eternal after death.
- 12. We believe that no one has a right to administer the Gospel Ordinances but such as are legally called and qualified there unto.
- 13. We believe it to be the duty of all church members to attend church meetings, and that it is the duty of the church to deal with them for neglecting the same.
- 14. We believe it to be the duty of all church members to contribute to the support of the church by defraying all reasonable expenses of same, never neglecting the poor, according to their several abilities.
- 15. We believe that any doctrine that goes to encourage or indulge the people in their sins or to cause them to settle down on anything short of saving grace in Christ for salvation is erroneous and such doctrine will be rejected by us.
- 16. None of the above articles shall be construed as to hold with particular election or reprobation as to make God partial directly or indirectly so as to injure children of men.
- 17. None of the above articles shall be altered without legal notice and free consent

RULES OF DECORUM

- 1. The association shall be opened and closed by prayer.
- 2. The moderator and clerk shall be chosen by the sufferage of the members present.
- 3. Only one member shall speak at a time, and shall rise from his seat and address the moderator, when he is about to speak.
- 4. The person thus speaking shall not be interrupted in his speech by anyone except the moderator until he is done.
- 5. He shall strictly adhere to his subject and in nowise reflect on the preceding speaker, but shall define his ideas on the proposition for debate, so far as he can.

- 6. No person shall abruptly absent himself from the association without leave of the same.
- 7. No person shall rise and speak more than three times on any subject without permission from the association.
- 8. No member of the association shall have the liberty to laugh during the sitting of the same, nor to whisper in time of public speech.
- No member shall address another in any other form or term than that of "brother".
- 10. The moderator shall not interrupt a brother or prohibit him from speaking until he gives his views on the subject unless he shall violate the Rules of Decorum.
- 11. The names of the several members of the association shall be enrolled by the clerk, and called as often as the Association may require.
- 12. The moderator shall be entitled to the same privileges of speech as any other member, provided the chair be filled, but he shall have no vote unless the association be equally divided in which event he shall give the deciding vote.
- 13. Any member who shall willfully and knowingly violate any of these rules shall be reprimanded by the Association as it may think proper.

CONSTITUTION

Having by unanimous voice changed our organization from an annual union meeting to an association, we therefore propose to keep the order and rules of an association according to the following form of government:

- 1. The association shall be called the Indian Bottom Association.
- 2. The association shall be composed of members chosen by the different churches in our union, and duly sent to represent them in the association, who shall be members whom they judge best qualified for that purpose, and producing letters from their respective churches, certifying to their appointment, these shall be entitled to a seat.
- 3. In the letters from the different churches shall be expressed their full number in fellowship, those baptized, received by letter, restoration, application, dismissed, excluded and deceased since our last association.
- 4. The members thus chosen and convened shall have no power to lord over God's heritage nor shall they have any clerical powers over the churches nor shall they infringe on any of the rights of any of the churches in the union
- 5. The association, when convened, shall be governed by a regular and proper decorum.
- 6. The association shall have a moderator and assistant moderator, clerk, and assistant clerk, and treasurer, who shall be chosen by the sufferage of the members present.
- 7. New churches may be admitted to this union, which shall petition by letter and delegates, and if found, upon examination to be orthodox and orderly, shall be received by the association, and manifested by the moderator giving the right hand of fellowship.
 - 8. Every church in the union shall be entitled to representation in

the association.

- 9. Every query presented by the churches to the association, being first debated in their own church, shall come under the consideration of the association
- 10. Every motion made and seconded shall be considered by the association, except it be withdrawn by the party who made it.
- 11. We think it absolutely necessary that we have an association fund, for defraying the expense of the same, for the raising of which we think it the duty of each church in the union to contribute such sums voluntarily as they think proper, and send it by their delegates, to be deposited with treasurer, who shall be responsible to the association for any pay the same out as the association may direct.
- 12. There shall be an association book kept in which the proceedings of every association shall be regularly recorded by the secretary, who shall receive annual compensation for same.
- 13. The minutes of the association shall be read and corrected, if need be, and signed by the moderator and clerk before the association rises.
- 14. Amendments to this plan of government may be made by a majority of the union when in regular session, when so desired.
- 15. The association shall endeavor to furnish the churches with minutes of the association, the best method of effecting the same shall be determined by the association.
- 16. All matters coming before the association shall be decided by will of the majority of the members present except in receiving and dismissing churches and associations, which shall be by unanimous vote.
- 17. The association shall have power to decide for the general union of the churches and to preserve an inviolable chain of communion among same, giving churches all necessary advice in matters of church difficulty; inquiring into the cause why any church shall have failed to represent itself any time in the association; appropriate the money received to any purpose it may think proper; appoint any member, or members by their consent to transact any business which it may think necessary; withdraw from any church in the union which may violate any of the rules of the association or deviate from the orthodox principles of religion, admit any orderly minister of our faith and order to a seat in the association and adjourn to any time or place it may deem necessary.

We know we can't see him any more on this earth but by the help of the good Lord we can see him in a world where trouble can not come.



Brother Leander leaves, besides his family, to mourn their loss, a host of friends and church brethren and sisters. His wife and loyal com-



He proved his love on the night of his call.




